

## Books in English

### **1. *The Politics of Foreign Aid: US Foreign Assistance and Aid to Israel:***

Praeger, 1988

This book deals with the US foreign aid programs in general and American aid to Israel in particular. It provides a historical analysis of the magnitude and development of American commitment to Israel and US economic and military assistance to the Jewish state; it analyses the role played by the Jewish lobby in Washington (AIPAC) in facilitating this assistance, and causing the US Middle East policy to be biased toward Israel and against the rights and aspirations of the Palestinian people. Although many years have past since this book was published, it remains the sole reference on this topic; no other books have been written, not because no one can write such a book, but because no has dared so far to do so. **(It could be obtained from publisher)**

### **2. *A Vision for the Transformation of the Middle East:***

Center for Educational Development, Washington DC, 1990

This booklet articulates an imaginative plan to resolve the Arab-Israeli conflict and bring peace, security and progress to the Middle East region through economic cooperation and new political and security arrangements. The proposal was translated and published in other languages and is included in the French encyclopedia of political science. **(Out of print)**

### **3. *The New World Order:***

Vantage Press, 1992

This book deals with the global developments that followed the demise of Marxism and disintegration of the Soviet Union. It identifies the major forces that led to the end of the Cold War era, and provides a perspective on what the world will look like in the future; it predicts that the national security of the great powers will be defined more in economic terms and less in military ones. It also provides new ideas to deal with some of the major problems and challenges facing the world, such as oil and energy, Third World debt, and peace in the Middle East and more. **(Out of print)**

### **4. *Conflict Resolution and the Middle East Peace Process:***

Duetsches Orient-Institut, Hamburg, Germany, 1993

This booklet deals with the Arab-Israeli conflict and the Middle East peace process, providing new ideas to help resolve it. It places the peace process in its proper conflict resolution framework and explains why it has so far failed to achieve its objectives. **(It could be obtained from publisher)**

### **5. *Conflict Resolution and Ethnicity:***

Praeger, 1994

This is the only book to articulate a theory of conflict resolution, relying on experience and theory to reach its conclusions. It uses theory to explain why negotiations often fail, and analyzes experience to construct process of negotiations and peace that have a good chance of success. It develops what it calls the “shared homeland” concept as a

framework to resolve ethnic and national conflicts around the globe, explaining how it applies to some of the most intractable conflicts in the world. **(It could be obtained from publisher)**

**6. *The US-PLO Dialogue:***

The University Press of Florida, 1995

The author, being the person who conceived the idea of the US-PLO dialogue, describes in detail the process that led the PLO to accept the American conditions for a dialogue, and led the US to recognize the PLO and open a dialogue with it. It also provides an analysis of the PLO decision making process and its leadership. All secret contacts that took place between Israelis and Palestinians starting in 1974 are revealed. **(It could be obtained from publisher)**

**7. *The Making of History:***

Authors Choice Press, 2001

This book deals with the past as well as with the future; it develops a new theory of history that differs from the conventional ones and identifies four major societal processes through which history is made. It provides many new ideas and unconventional approaches to understanding the world we live in and explains, for example, why Third World nations have failed to develop and embrace democracy; it analysis the ideas of Samuel Huntington and Francis Fukuyama regarding the clash of civilizations and the end of history, respectively, and uncovers the misconceptions, biases and fallacies they contain and promote. **(It could be obtained from [iuniverse.com](http://iuniverse.com))**
